

PLEASE NOTE!

Our cancellation policy has changed.

In the event that:

- the shooter cancels their participation for personal reasons,
- the event is cancelled by the organiser in the event of force majeure.

* If the cancellation is made MORE THAN 45 days before any competition in the Sporting discipline / MORE THAN 30 days before a competition in any other discipline, your entry will be reimbursed by the FITASC after deducting a 10% administration fee.

* If the cancellation is made LESS THAN 45 days before any competition in the Sporting discipline / LESS THAN 30 days before a competition in any other discipline, there will be NO REFUND.

If you wish to receive a full refund of your competition entry fee in the event of individual cancellation for serious personal reasons (serious illness, physical injury or death or any guaranteed random event that can be justified), or if the event is cancelled by the organiser in the event of force majeure, we advise you to take out an individual ALL JUSTIFIED REASONS cancellation insurance, which will be offered to you at the start of the registration process.

IMPORTANT: The individual ALL JUSTIFIED REASONS cancellation insurance can ONLY be taken out when you register online for the competition.

These cancellation conditions apply to all competitions from 1 January 2025.

You can find details of the different cancellation scenarios and a simulation of the insurance premium and refunds in paragraphs 5 and 6 of our General Conditions of Registration.

INDIVIDUAL ENTRY CONDITIONS

Dear Shooter,

You wish to enter a competition organised under the auspices of the Fitasc by one of its members. Before confirming your registration, please read the following terms and conditions carefully:

1. ENTRY CONDITIONS

- Fitasc competitions are reserved for shooters belonging to their national federation, which must be a Fitasc member for the discipline concerned. Shooters wishing to enter a Fitasc competition must not be in contravention of the rules of their national federation, notably in respect of payment of their membership fees.
- Only shooters reaching the age of thirteen years during the year of the competition concerned may enter Fitasc competitions (except with the authorization of the home federation, which must be accompanied by parental permission and a medical certificate stating that the person concerned is fit to take part in clay-pigeon shooting).
- By entering a competition, shooters implicitly undertake to observe all the provisions of the Fitasc's rules and the rules of the competition concerned.
- By entering a competition, shooters implicitly waive their image rights and authorise the Fitasc and/or the organisers of the competition concerned to use any images made of them during the competition and to distribute such images via any means whatsoever, though without infringing their privacy.

2. MANDATORY PERSONAL LIABILITY INSURANCE

- Each shooter must hold a valid individual civil liability insurance policy covering participation in clay-pigeon shooting and related disciplines and all its forms throughout the world or, in any event, in the country organising the competition concerned.

3. MEDICAL RECOMMENDATIONS

The conditions in which FITASC competitions take place can be physically demanding, particularly on the discipline Sporting (high temperatures, walking on rough terrain, slippery floor). Also, before any registration, shooters with chronic diseases (notably cardiovascular, renal, metabolic, joint) must ensure the absence of contraindications, by seeking the advice of their attending physician if necessary. In all cases, it is imperative to bring your usual medication, and take it regularly throughout the competition.

4. ENTRY AND PAYMENT PROCEDURES

- Competition places are reserved in order of receipt of the entries and subject to the number of places available. Entries become final and are confirmed only after collection of payment.
- Competitions are organised as full-day events or divided into half-days. If the competition is organised in half-days, the shooter may indicate on the registration form whether they prefer to be in the morning group or the afternoon group for the first day. This preference will be taken into account as much as possible, in order of registration and subject to the number of places available on each half-day. If for any reason the organiser decides to change the competition schedule, the FITASC cannot be held responsible for the consequences of this change. Consequently, each shooter undertakes to check on the eve of the competition the exact time when he/she is due to start shooting.
- To register for a FITASC competition, complete and submit the registration form on the FITASC website.
- Each entry form must be used for one shooter only and one competition only.
- Shooters undertake to complete entry forms honestly and accurately, otherwise the Fitasc reserves the right to cancel entries without refunds. During the entry period, the national federations check that the shooters that have entered individually are federation members and are up to date with their membership fees.
- If, when the shooter fills out the registration form on the internet, the limit on the number of participants has been reached, the shooter is automatically placed on a 'waiting list', which does not have any order

of priority. If places become available, the shooters on the waiting list are immediately informed by email. The final registration of shooters is made according to the order in which payments are received, made solely by secure 'online' payment on the FITASC website, and subject to the number of places available.

- The Fitasc reserves the right, at the latest one month before the start of the competition, to reduce or increase the maximum number of entries for a competition according to the trend in the actual number of shooters entered and the technical conditions for catering for shooters.

Before a shooter's confirmed entry for a competition, the Fitasc may not be held liable on any basis whatsoever and for any reason whatsoever for any consequences (expenses for bookings, travel, hotel accommodation and any other ancillary costs, whether direct or indirect) of the following:

- cancellation of the scheduled competition;
- postponement;
- change of location;
- change in the number of days of competition.

6. INDIVIDUAL REGISTRATION CANCELLATION INSURANCE

Each shooter has the option, if they so wish, of taking out individual insurance to cover simultaneously:

- their personal risk of having to withdraw from a competition if an event beyond their control occurs and is justified,
- the risk that the competition will be cancelled following the occurrence of an event of force majeure.

Cancellation insurance can only be taken out when you register online for the competition.
