YOUR RIGHT TO PRIVACY AND CONFIDENTIALITY

The CTSASA respects the privacy of our members' personal data and has sought legal advice on this matter. Under section 11 of the POPI Act, before we submit any personal information to SASSCo, we are required to inform you of this request and to provide you with an opportunity to object.

IF YOU DO NOT CONSENT, PLEASE NOTIFY THE CTSASA BY 18TH AUGUST 2026

If you do not consent to your personal information being submitted to SASSCo, SASCOC, DSAC or the Auditor General, **please email the CTSASA at info@ctsasa.co.za** by no later than close of business on Tuesday, 18th August 2026.

HOW YOUR PERSONAL INFORMATION WILL BE PROCESSED/USED

SASSCo's stated purposes for requiring this information are detailed below:

- a) Reporting to the Minister for Sport, Arts and Culture. The Department of Sport, Arts and Culture (DSAC) has stated :

"The personal information may be disclosed by the Department to third parties in the normal course of business or as needed to comply with its legal obligations."

"The Department processes the Beneficiary's personal information included in the Agreement to perform its public law duties and undertakes to comply with the Protection of Personal Information Act 2013"

"The Auditor General is regarded as a Third Party."

- b) Support applications by SASSCo for local and international funds to develop the shooting sports.
- c) SASSCo has further stated that it (SASSCo) "requires the ID number to validate members for application for national and confederation colours. SASCOC is in the process of creating a digital platform that will assist in the application process and to eliminate duplication and conflicting information".
